  - o requests for additional client information
  - requests for clarification on the FFIs Registration or Reporting
  - reporting of non-compliance and remediation requirements
- In addition, the Responsible Officer for the FFI will have to autocertify to the IRS on the FFIs status of compliance, any instances of non-compliance and remediation taking place.
- Footman can support and advise our clients throughout all of this communication process. Typically, to facilitate this process, our client would assign a Foodman FATCA specialist as one of the Points of Contact of the FFIs registration.

### Annual FATCA Update
